2. Specific Terms of Reference assigned to the Monitoring Committee are :

To monitor the physical and financial progress of intervention brought about in the Bundelkhand area as per the Special Package.

To consider the reports to be periodically submitted by National Rainfed Area Authority on progress of implementation of the Special Package for Drought Mitigation of Bundelkhand region, and to review following-up actions.

To review overall guideline for speedy implementation of the schemes.

To Provide guidance, clarification and modifications wherever required in implementation of the Special Package for integrated development of Bundelkhand region.

3. The committee will prepare a report every quarter or at such interval as decided by the committee.

4. The Monitoring Committee may co-opt/invite any other official/non-official expert/representative of any organization as member (s)/Special invitee, if required and may devise its own procedures for conducting its business including meetings.

5. The Monitoring Committee may examine and address issues which are important but are not specifically spelt out in the above To Rs.

6. The expenditure of the official Members on TA/DA in connection with the meeting of the Monitoring committee will be borne by the Ministry/Department/State Government to which they belong. In case of non-officials, the TA/DA will be borne by the planning Commission as admissible to the class-I officers of the Government of India.
